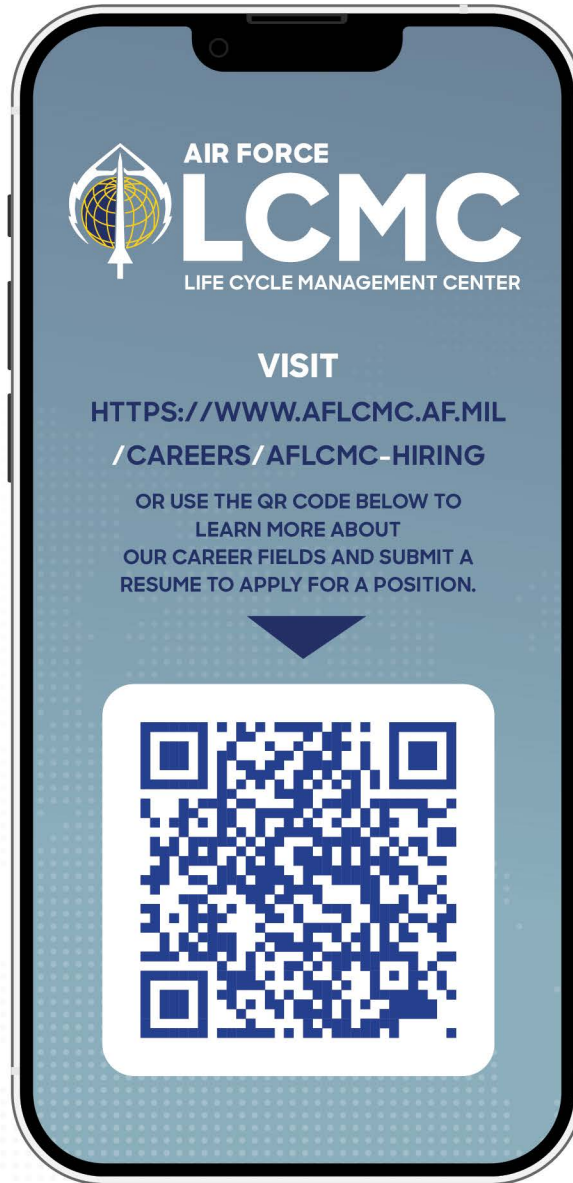
Thrift Savings Plan (TSP) is our 401k-style retirement program with very low management fees and a 5 percent agency match
